The requirements of 3.3.2 Early Concept Proposal on Page 9 of the Work Rules are updated to help design teams better understand the requirements on the early concept proposal in the open call stage. The update details are provided below.

概念提案文本 A3 规格 (297mm*420mm)，1 正 7 副，不超过 4 个图文页面 (页数限制不含封面封底及扉页)，简装。正本须在封面注明设计团队名称，并加盖公章及主创签字。副本不体现设计团队名称或其他与设计团队相关的信息。

The early concept proposal package should include one original and seven duplicate copies in A3 size (297mm*420mm), each containing no more than four pages of drawings and narratives (excluding front and back covers and title page) and in paperback form. The original copy must bear the name of the design team, its corporate seal and the chief designer's signature on the cover, while the duplicate copies should avoid to show the design team's name and other relevant

information.

主要阐述对项目的理解和设计总体思路，可采用多种形式，图文混排，要求包含但不限于如下内容：概念设计草案及必要的说明和分析。

The early concept proposal should present the project understanding and overall design thought in various forms as needed, such as mixed layout of narratives and drawings. It should include but is not limited to the following contents: the draft conceptual design and necessary narratives and analyses.
